## Upper East Side Rehabilitation and Nursing Center COVID-19 Visitation Fact Sheet

NYS Department of Health issued a Health Advisory on March 25, 2021, advising visitation may be expanded, beginning March 25, 2021, as long as there are certain core principles and best practices that reduce the risk of COVID-19 transmission including, but not limited to:

- 1. Visiting shall be:
  - Daily by appointment only. Appointments must be scheduled at least 1 day in advance. Visiting hours are:
    - Monday-Friday: Every half hour from 10:00am-12:00pm and 1:00pm-5:00pm.
    - Saturday-Sunday: Every half hour from 10:00am-12:00pm and 1:00pm-4:00pm.
  - Held in outdoor areas whenever practicable, except under certain limited circumstances (see #6 below).
  - Permitted indoors, in a well-ventilated space, while observing appropriate social distancing and the use a face mask or face covering while in the presence of others, so long as the COVID-19 county positivity rate is less than ten percent (10%). Indoor visitation may be limited under certain circumstances as determined by the Facility due to a high risk of COVID-19 transmission.
  - Limited to family members, loved ones, and representatives from the long-term care ombudsman program (LTCOP) and resident advocacy organizations.
  - Limited to two (2) visitors per resident per day.
- 2. Given the continued risk of COVID-19 transmission, the NYS Department of Health emphasizes the importance of maintaining infection prevention practices and strongly recommends that the Facility continues to offer testing to visitors to help reduce any such risk of COVID-19 transmission. Testing for visitors is encouraged and available if desired.
- 3. Visitors must wear a face mask or face covering that covers the nose and mouth when on the premises.
- 4. Residents, visitors, representatives of the long-term care ombudsman and resident advocacy organizations (collectively "Visitors") will be required to appropriately use an alcohol-based hand sanitizer, consisting of at least 60 percent (60%) alcohol, provided by the Facility, prior to visiting the residents.
- 5. Visitors must maintain social distancing, except when assisting with wheelchair mobility.
- 6. Outdoor visitation is preferred even when the resident and visitor are fully vaccinated\* against COVID-19.
- 7. The Facility will screen Visitors for signs and symptoms of COVID-19 prior to resident access and will prohibit Visitor(s) exhibiting any COVID-19 symptoms or that do not pass the screening questions.

- Screening shall consist of both temperature checks and asking screening questions to assess potential exposure to COVID-19 which shall include questions regarding international travel or travel to restricted states designated under the <u>Commissioner's COVID-19 Travel Advisory</u> (<u>https://coronavirus.health.ny.gov/covid-19-travel-advisory</u>). Please note that if you have visited any of the Restricted States or have travelled internationally within the last fourteen (14) days, visitation will <u>NOT</u> be permitted.
  - a. The following information must be provided for each visitor: first and last name of the visitor; physical (street) address of the visitor; daytime and evening telephone number; date and time of visit; and email address, if available. - 9. Visitors under the age of 18 years old MUST be accompanied by an adult 18 years of age or older.
- 10. Current COVID 19 positive residents, residents with COVID 19 signs or symptoms, and residents in a 14day quarantine or observation period remain ineligible for in person visits.
  - a. Residents who are on transmission-based precautions for COVID-19 should only receive visits that are virtual or through windows
- 11. A copy of the Facility's formal visitation plan is posted on the website.
- 12. The staff is required to monitor the visitation process. In accordance with the NYSDOH March 23, 2021 Health Advisory, if any visitor fails to adhere to the Facility's visitation plan, he/she/they will be prohibited from visiting for the duration of the COVID-19 state declared public health emergency.
